

## Medical Consent and Waiver

I, the parent/guardian of the registrant, a minor, agree that I and the registrant will abide by the rules of the United States Youth Soccer Association (USYSA), its affiliated organizations and sponsors. Recognizing the possibility of physical injury associated with soccer and in consideration for the USYSA accepting the registrant for its soccer programs and activities ("The Programs"). I hereby release, discharge and/or otherwise indemnify the USYSA, its affiliated organizations and sponsors, their employees and associated personnel, including the owners of fields and facilities utilized for The Programs, against any claim by or on behalf of the registrant as a result of the registrant's participation in the Programs and/or being transported to or from the same, which transportation I hereby authorize.

**Medical Consent:** As the parent or legal guardian of the registrant, I hereby give my consent for emergency medical care prescribed by a duly licensed Doctor of Medicine or Doctor of Dentistry. This care may be given under whatever conditions are necessary to preserve the life, limb or well being of my dependant.

**RHSC Waiver:** I, parent/legal guardian of the registrant, a minor, agree that I and the registrant will abide by the rules & policies of the Red Hook Soccer Club, Inc. ("RHSC"), its affiliated organizations and sponsors. Recognizing the possibility of physical injury associated with soccer and in consideration for the RHSC accepting the registrant for its soccer programs and activities ("Programs"), I hereby release, discharge and/or otherwise indemnify the RHSC, its affiliated organizations and sponsors and their employees and associated personal, including the owners of the fields and facilities utilized for the Programs and/or being transported to or from the same, which transportation I hereby authorize.

**RHSC Code of Conduct:** I hereby pledge to provide support to the Red Hook Soccer Club Inc. ("RHSC") programs purpose of developing characteristics of honesty, good fellowship, self-discipline, respect, team play, fairness, and self-reliance, which are the essentials of good sportsmanship, by following the RHSC Code of Conduct:

- 1.) I, my guests, and my child will demonstrate good sportsmanship by showing respect and courtesy, and by offering positive support for all players, spectators, coaches, and officials at games, practices or other RHSC sponsored events.
- 2.) I, my guests, and my child will treat other players, spectators, coaches, and officials with respect regardless of race, gender, color, creed or ability.
- 3.) I will demand for my child a sports environment that is free from drugs, tobacco, and alcohol, and I will refrain from their use at RHSC sports events.
- 4.) I will not force my child to participate in RHSC sports events.
- 5.) I will inform the RHSC and coaches of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 6.) I will remember that the program activities are for the players enjoyment, with the emphasis on fun, skill development and practice.
- 7.) I will place the emotional and physical well-being of the players above and personal desire to win.
- 8.) I will teach my child that doing one's best is more important than winning.
- 9.) I and my child will learn the rules of soccer and the Policies of the RHSC.
- 10.) I will refrain from coaching players during games unless I am one of the official coaches of the team.
- 11.) I, my guests, and my child will properly use and care for RHSC property, and will make questionably unsafe conditions immediately aware to the RHSC and coaches.

I have read and understood this Code of Conduct as described above. I am aware that failure to abide by this Code of Conduct may result in my, and/or my child's suspension from all RHSC sponsored activities. I recognize that failure to sign this Code of Conduct makes my child ineligible to participate in any RHSC sponsored activities for the program year.
